I. CALL TO ORDER

Pursuant to the meeting notice, a special teleconference meeting of the California Fair Services Authority (CFSA) Board of Directors was convened at 10:05 a.m., April 30, 2020, by Board Chair Steven Kenny and roll call was taken.

II. DISCUSSION ON OVERVIEW OF COVID-19 IMPACTS

Executive Director Rebecca Desmond briefed the Board on recent developments related to the impacts of COVID-19 on the California fair industry and CFSA.

III. ADOPTION OF RESOLUTION DELEGATING AUTHORITY TO AN AD HOC BOARD COMMITTEE AND THE EXECUTIVE DIRECTOR TO NON-RENEW THE CFSA GROUP PURCHASE PROPERTY PROPERTY INSURANCE PROGRAM FOR 2020-2021

The possibility of our member fairgrounds being without any source of revenue for the rest of 2020 added more uncertainty to the sustainability of the CFSA Group Purchase Property Insurance Program. Staff will continue to gather input from program participants as to their ability to participate in the 2020-2021 program and work with our broker Alliant on options. Alliant has other property insurance programs available to individual fairgrounds that would be good alternatives if CFSA is unable to continue the voluntary group purchase program.

Moved by Director Blyskal and seconded by Director Wolcott to adopt **Resolution No. 20-22** delegating authority to an ad hoc committee of the Board and the Executive Director to not renew the CFSA Group Purchase Property Insurance Program for the 2020-2021 program year should the number of fair participants fall below the necessary threshold to renew the policy or should renewing participants not make payment of full premiums by June 15, 2020.

Directors Jack Blyskal and Lori Marshall were named to the committee by Chair Kenny.

Director Dan Jacobs stated on the record that he serves as the Vice Chair of the California Fairs Alliance, a division of the non-profit Western Fairs Association, for notation in CFSA's official records. Director Jacobs disqualified himself from

participation in this agenda item.

Western Fairs Association/California Fairs Alliance is seeking funding from various partners to support an enhanced comprehensive advocacy campaign for the Network of California Fairs in light of the immediate fiscal crisis facing the fairs and fair-related agencies due to COVID-19.

Moved by Director Blyskal and seconded by Director Marshall to adopt **Resolution No. 20-23** to (i) authorize an amendment to the partnership agreement with Western Fairs Association (WFA) which will include CFSA as part of the WFA/California Fairs Alliance enhanced advocacy program in light of the fiscal crisis facing the Network of California Fairs, for which CFSA will provide WFA with \$25,000.00 in support of the program; and (ii) authorizes the Board Chair to execute the amendment in a form approved by CFSA legal counsel.
