Pursuant to the meeting notice, a special teleconference meeting of the California Fair Services Authority (CFSA) Board of Directors was convened at 10:02 a.m., June 17, 2020, by Board Chair Stephen Kenny and roll call was taken.

II. ADOPTION OF RESOLUTION APPROVING APPLICATION OF ONE-TIME FEE CREDIT TO GENERAL LIABILITY AND WORKERS' COMPENSATION RISK POOLING PROGRAM PARTICIPANTS

Staff has been working with our actuary Bickmore Actuarial, our excess coverage carrier PRISM, and our broker Alliant on recalculating loss projections and excess renewals in the General Liability and Workers' Compensation Programs. These recalculations are based upon revised program participant payroll and revenue estimates due to the COVID-19 pandemic.

With those actions, we are able to provide an overall \$2.7 million risk pool fee credit to our pool participants for 2020.
