Staff received an inquiry from a member wishing to book a "smash room" on the fairgrounds. This is a fully portable, enclosed unit where patrons smash items. This activity is not specifically listed on our Hazardous/Nonhazardous Activities List, and we wish to add it at this time.

In an effort to not have to bring the simple revisions to the Hazardous/Nonhazardous Activities List to the board several times a year as specific unlisted activities are brought to our attention; we have inserted the language "All types including but limited to" all of the hazardous categories in order to give CFSA staff discretion to assign unlisted specific activities to a listed category.

Activities that come to our attention that staff believes need to be named specifically as a hazardous activity due to the high exposure of the activity will still come before the board to be added to the Hazardous/Nonhazardous Activities List.
